• Conduct robust community engagement throughout the project — from design to implementation.

# Build Community Strength

 Develop strategies to increase the likelihood that benefits of the investments accrue to existing residents of disadvantaged communities, both immediately and sustainably beyond the grant period.

- A microgrid is a self-sufficient energy system that serves a discrete geographic footprint, such as a college campus, hospital complex, business center or neighborhood.
- Within microgrids are one or more kinds of distributed energy (solar panels, wind turbines, combined heat and power, generators) that produce its power. In addition, many newer microgrids contain energy storage, typically from batteries.
- Microgrid provides electricity and possibly heat and cooling for its customers, delivered via sophisticated software and control systems.

- This plan should describe how the applicant will engage, educate, and be responsive to community members throughout project development and / or implementation.
- There are three components.
- NOFO Section I.G contains detailed requirements.

1. Past Community Outreach & Engagement Conducted 2. Community Engagement Plan Implementation 3. Collaborative Governance Structure

Demonstrate what outreach and engagement methods were used to engage with the Project Area community Demonstrate the specific community engagement methods, as well as how they will mitigate barriers and involve relevant stakeholders

Provide details regarding the roles and responsibilities of the Lead Applicant, Collaborating Entities, and community residents and / or communityselected representatives

# **2. Community Engagement Plan Implementation** (1 of 3)

Clear Methods for Engagement & Transparency NOFO Highlights:

- Methods to involve diverse community participation.
- Transparent mechanisms to provide meaningful accountability to community needs and preferences.
- Community communication channels before, during, and after project implementation.

Things to consider during plan development

- > A multifaceted approach fosters broader awareness and participation.
- Keep in mind accessibility and select a range of approaches that provide access to all community members.


Things to consider during plan development



Consider linguistic differences How will you accommodate for limited-English proficient and hearing-impaired members in the community?



Plan for communication challenges Will there be a virtual option? How will you accommodate varying schedules?



Address difficulty in reaching all community segments What platform will be used to advertise engagement opportunities?





# 2. Community Engagement Plan Implementation (3 of 3)

# E.J

*Government Involvement* NOFO Highlights:

- Details how the support and involvement of government agencies will lead to successful performance.
- Consider the spectrum of government agencies from the Federal government, State agencies, Localities (county, city, political subdivisions) and Tribal governments.
- (If applicable) the previous collaboration with government agencies and planned activities to include government agencies throughout the project.

See NOFO Section I.G for complete requirements

Things to consider during plan development

- Early identification and engagement with relevant agencies enhances support and impacts awareness of the project.
- To be eligible for funding, Lead Applicant must include in the application a copy of a written and signed Partnership Agreement with the Statutory Partner that is legally binding. (Reference Appendix B for more information)



- There may be plan or policy changes that impact your project.
- Stay tuned to relevant city council/county commissioner/state hearings that may impact your project.

- Reach out to County and Municipal Governments or the Departments of Energy, Water, Public Health, Economic Development.
- Notify the following entities above of the Community Change Grant.



## 3. Collaborative Governance Structure

### NOFO Highlights:

- Establish clear coordination strategies and transparent decision-making processes between the Lead Applicant and Collaborating Entities.
- Diverse outreach methods to ensure equitable participations.
- Processes for replacing Collaborating Entities to maintain project integrity (Requires EPA-Approval).

Things to consider during plan development

Plan for contingencies! How will you evaluate the replacement has comparable skills and community support?

The importance of a Collaborative Governance Structure: What: An approach that is dedicated to public problem solving. Give community members a setting to express their opinions.

Who: Members of the community and other stakeholders. Create a structure that involves community decision making, debating issues, and cross-collaborating with other stakeholders to produce outcomes that have the power to benefit the community.

How: Create roles and give responsibility to community members and establish regular cadence to discuss project implementation.

# **Community Strength Plan**

• This plan should describe how the applicant will bolster the strength and economic prosperity of a community for the benefit of the residents.

- There are two components.
- NOFO Section I.G contains detailed requirements.

1. Maximizing Economic Benefits of Projects

2. Displacement Avoidance

Demonstrate how to maximize economic benefits for individuals in the Project Area through Business Opportunities, Job Opportunities, and Financial Savings. Demonstrate an increase in benefits for community members both in the short and long term and assess displacement risks and incorporate mitigation strategies for current and future residents.



# **1. Maximizing Economic Benefits of Projects** (1 of 3)

Business opportunities NOFO Highlights:

- Steps taken to promote business opportunities within the project area.
- Plan to inform local businesses of open solicitations and encourage them to compete for contracts.
- Make a "good faith effort" to provide disadvantaged business enterprises (DBEs) with an opportunity to compete for contracts in accordance with EPA's 40 CFR Part 33 Disadvantaged Business Enterprise rule.

#### Things to consider during plan development

The Project must follow open (competitive) procurement processes when engaging with private businesses and needs to develop a plan to solicit and review multiple bids.







## 1. Maximizing Economic Benefits of Projects (2 of 3)

Job opportunities NOFO Highlights:

- Propose measures to facilitate the employment and retention of workers from disadvantaged communities on funded projects.
- Propose measures to increase community awareness of job opportunities and the associated skill requirements.
- Describe specific measures that will ensure Project Area residents are developing skills that are necessary to take advantage of existing or future jobs in professions contributing to the reduction of pollutants.

Things to consider during plan development



Fund supportive services for workers on grant-funded projects

Consider partnering with local social service providers to support transportation, childcare, mental health for these workers.



Partner with your local workforce development board The local workforce development board may be able to inform effective recruitment strategies in the Project Area.



Establish goals for hiring individuals from disadvantaged communities *How are you transparently tracking progress towards those goals?* 



Create high-quality jobs

Consider promoting best practices with contractors on equal opportunity hiring, benefits, organizational culture, and advancement.



## 1. Maximizing Economic Benefits of Projects (3 of 3)

Financial Savings NOFO Highlights:

- The connection between the community's direct economic benefits and the Climate Action and Pollution Reduction projects.
- How the project plans to deliver benefits for residents in both the short-term and long-term.

Establish economic advantages of project initiatives

NOFO Highlights:

- Potential short-term and long-term risks associated with the proposed projects to residents, small businesses, non-profits, and other community members.
- Assess the community's vulnerability to rising costs and its potential impacts and navigate how to mitigate this risk.
- How to ensure benefits are kept within the community.

Things to consider during plan development

Describe any existing policies, ordinances, programs, or work underway in the Project Area that mitigates risk of displacement.

Government Collaboration	Sample Outreach Approach	Sample Climate Action and Pollution Strategy Approach	Sample Landlord Approach
Describe how applicant will work with relevant entities, to create policies, plans, or programs to mitigate unintended impacts of EPA- funded investments.	Outreach to residents using information packets and workshops that feature information about tenant rights for a project that may have the unintended effect of raising rents.	A strategy that promotes increased housing density as a tool to reduce emissions could have the co-benefit of reducing housing costs by increasing housing supply.	Securing landlord commitments for EPA- funded property improvements to maintain affordable housing and prevent rent increases.

requirements are described in Section IV.B of the NOFO. The Track I Project Narrative 20- page limit does
not include the Community Engagement and Collaborative Governance or Community Strength Plans.
There are separate page limits for those plans. Please see the relevant parts of the Section IV.B Track I
application requirements.

• While a regional, county, or statewide project may technically be eligible, depending on the specific content of an application, it may be unlikely that such an application would score well and be successful considering the NOFO evaluation criteria, objectives, and requirements.
